

Annual Report 2022-23

From the Chair, on behalf of the committee

It has been another busy year for CPRE, the countryside charity, and CPRE Derbyshire, mainly due to the government looking at changing some of the key principles and legislation in respect of the current planning system.

These changes include trying to remove some of the important protections and the voice of local communities in raising objections to large scale industrial development and housing projects in the countryside.

Whether it is under the guise of National Infrastructure Projects or the new proposed legislation in the Levelling Up and Regeneration Bill of National Development Management Policies (NDMPs), the proposals give government the authority that NDMPs take precedence over local development plans. This is something which we are totally opposed to. At CPRE Derbyshire, we have continued to monitor, review and submit objections to developments that we think are detrimental to the countryside, across all eight districts of Derbyshire that we cover, with the exception of applications in the Peak District National Park, which are covered by CPRE Peak District and South Yorkshire (CPRE PDSY).

In addition for some strange historic reasons, CPRE PDSY also cover six parishes in the north of North East Derbyshire and we have asked for these areas to be returned us to avoid having two interfaces with North East Derbyshire District Council.

We still have one committee member allocated to covering applications from each of the eight districts. The results of which are fed into our Planning Sub-Committee under our Vice Chair, Isabella Stone. From this meeting we make decisions on which applications we are going to raise objections against, and which we are not.

This year we have continued to see a number of proposals for very large-scale solar farms, notably in South Derbyshire, North East Derbyshire, Amber Valley and Bolsover.

We successfully defended the appeal of the developer on the Alfreton Solar Farm proposal with the support of Amber Valley Borough Council, Save the Alfreton Countryside and other like- minded groups. This also led to the developer to commit to withdrawing their application for another large scale solar farm proposal in Shirland, the next village along.

CPRE National raised two very interesting reports in this space, one on food security which stated too much good agricultural land was being allocated to house building or to large scale solar farms, and that we need to protect our best agricultural land for growing food. The second one was issued at the end of May 2023 on Rooftop Renewables, which stated that 60% of the solar power the country needs can be sited on rooftops. We need to help shift the mindset of the UK Solar Industry to a rooftop/ carpark first approach.



As mentioned in previous annual reports, we have been running the Three Counties (3C) Project for the last 24 months, and this sadly has now come to an end .

This project, for the first fourteen months, funded one day a week of social media/ website updates for our Group and one day of community engagement and volunteer coordination recruitment. We have continued to see significant increases in followers (Facebook, Twitter and Instagram) and better engagement with their users. It is local articles that still draw the most interest from our followers.

The last ten months of the 3C Project has been focused on running the Hedgerow Heroes Project. This delivered 2.2 km of hedgerows (planting and laying) across eleven sites in Derbyshire, Leicestershire, Lincolnshire and Nottinghamshire, and introduced a large number of new volunteers to CPRE East Midlands Groups. Overall the Project was seen to be a great success and we applied for further grants to run similar projects in 2024. Unfortunately the CPRE Derbyshire, Leicestershire and Nottinghamshire bids were unsuccessful, but other CPRE groups will receive circa £0.5m to fund their projects in 2024.

I would like to thank Lorraine Ray, Lewis Townsend and Eleanor Cheetham for the support they have given CPRE Derbyshire, CPRE Nottinghamshire and CPRE Lincolnshire over the last two years and wish them every success for the future. On the positive side, Lewis is now working for the central CPRE team, so we will continue to work with him going forwards.

A report was issued in February 2023 accompanied by some artist representations of how renewable energy sources would look within the landscape of the village and surrounding area. The village of Bonsall, under local resident Wendy Bullar, has now set up a Renewable Energy Action group to see how they can turn this vision into a future reality for the village.

We have also decided that we need to communicate with our members and our community partners more often, so we have decided to introduce a quarterly newsletter. Hopefully you enjoyed the first edition issued in March, and this annual report. Please feel free to provide us with any feedback. Hedgerows Heroes

The Hedgerow Heroes project, which also supports CPRE's national hedgerow campaign, helped to restore hedgerow in three sites in Derbyshire.

Having secured joint funding with Nottinghamshire, Lincolnshire and Leicestershire, we embarked on a mission to create and restore hedgerows in Derbyshire. With our aim to directly engage with communities and volunteers, we partnered with TCV (The Conservation Volunteers), Groundwork and Derbyshire County Council and worked with local volunteers and CPRE members.

Volunteers and our partners worked together on three Derbyshire sites: Hooks Farm Dairy, Borrowash, Whistlewood Common, Melbourne and Williamthorpe Nature Reserve, part of the Five Pits Trail near Clay Cross.

At Williamthorpe and Whistlewood Common, volunteers were trained in the traditional art of hedge-laying. By partly cutting through the trunks of the trees and shrubs of an established hedge and arching and weaving the branches together (pleaching), hedge-laying encourages new growth and strengthens and rejuvenates the structure of the hedge, keeping it healthy and blooming. Over the winter of 2022-23, we joined three other East Midlands counties in our Hedgerow Heroes project, part of CPRE's aim to increase the hedgerow network by 40% by 2050. This target was recently accepted by the government, after CPRE's campaign, in answer to the Climate Change Committee's call to help achieve carbon net zero.

Overall, between November 2022 and March 2023, we pleached 500 metres of hedge, involved 64 volunteers over 16 sessions and planted 1000 saplings to thicken established hedges and generate new ones. We used native hedgerow plants such as blackthorn, field maple, hawthorn, holly, hazel and dog rose to create wildlife corridors, habitat and food sources for insects, birds and mammals whilst also supporting natural carbon capture and drainage plus shelter for livestock.

CPRE Derbyshire is proud to have successfully contributed to preserving and increasing hedgerow in our locality.

Hedgelife Help Out

An update on the hedges at Williamthorpe post pleaching and planting

Hedgelife Help Out is a new volunteering activity launched by CPRE as part of the Coronation Big Help Out.

Hedgelife Helpout was designed by CPRE in collaboration with The Tree Council, of which CPRE is a member. It aims to help assess the health of our hedges.

A group of volunteers and Groundwork staff took the opportunity in May to revisit the Williamthorpe Nature Reserve, where our recent hedge-laying and planting took place, and to undertake the Hedgelife Help Out survey.

The group inspected the newly planted hedging, which was springing into life and vigorous, and the stretch that the volunteers layed was healthy and full of leaf and blossom.

Participants then completed online Hedgelife Help Out surveys, based on straight forward observations, on various stretches of hedge on the reserve and submitted the results to help build up a picture of the nation's hedgerows.

Planning update for the last 12 months

Solar farms in the countryside

More and more planning applications for development in open countryside are for solar farms, some very large scale.

CPRE Derbyshire promotes renewable energy installations on brownfield land and rooftops, rather than green field sites. National CPRE's recent report on Rooftop Renewables supports this view.

In the last year we have objected to a number of solar farm proposals, which would have an unacceptably damaging impact on local landscapes and amenity:

Victory at Alfreton Solar Farm Appeal

We joined the Save Alfreton Countryside action group to prevent a 185 acre solar farm blighting the landscape north of Alfreton.

The developers appealed against the borough council's refusal which meant that the final decision was made by the government's Planning Inspectorate.

CPRE Derbyshire gave evidence at the appeal hearing in October 2022. Ultimately the Inspector accepted our case that the development would have an unacceptable impact on the landscape character of the area and irrevocably harm the last remaining countryside directly accessible on foot from Alfreton. Lullington Solar Farm – Appeal result awaited A potential solar farm capable of powering 15,000 homes set in the Derbyshire countryside on agricultural land between Coton in the Elms and Lullington in South Derbyshire was refused in 2022 by South Derbyshire District Council, following hundreds of objections, including our own. The developers have appealed the decision and we await the decision by the Planning Inspectorate.

100-acre solar farm near Creswell and Elmton

A proposed utility-scale solar farm on the outskirts of two Derbyshire villages would see more than 100 acres of good quality agricultural land converted. The site, which is roughly the size of 60 football pitches, is positioned on Frithwood Lane, between the north Derbyshire villages of Creswell and Elmton. If approved this would be the fourth solar farm in the area - with the 25,000-panel Creswell Solar farm just northeast of the proposed site. We have objected and await the outcome.

Battery Energy Storage System at Calow

Another aspect of increased renewable energy generation is the installation of energy storage systems to cope with intermittent supply. We are keeping a close eye on such developments for their impact on the landscape and on rural tranquility – they emit a constant audible hum and also cause light pollution. One such example is a proposal at Back Lane, Calow – we have submitted an objection.

CPRE Derbyshire is realistic about the expansion of renewable energy generation as a critical part of delivering our net carbon neutral targets.

We are supportive in principle of well-planned developments of this nature that also account thoroughly for local needs.

In practice, however, we apply the same principles to evaluate the location, design and impact of such sites as to any other development taking place in the countryside and considering national and local planning policy.



Planning update continued

Other Planning Objections in 2022/23

We continued to review all kinds of development proposals in the countryside over the last year. Here are some highlights:

Knockerdown, Carsington Water

We were particularly pleased that Derbyshire Dales District Council (DDDC) agreed with us and local residents that a car-based leisure facility at Carsington, submitted by Caffeine and Machine, was totally inappropriate in this rural location.

Land South of Main Road, Brailsford

A proposal for 100 houses on open countryside adjacent to the Brailsford Conservation area was thankfully refused by DDDC. We objected to the development of this green field site with far reaching views across the landscape. The number of housed in the village has almost doubled in the last few years – this development would have been a step too far.

Chaddesden Wood, Oakwood, Derby

150 houses proposed in open countryside and woodland just north of Derby, an area much loved and enjoyed by local people. We submitted a strong objection – to date over 700 have been registered and we await a decision by the city council. Holiday Lodges, Longwalls Lane, Blackbrook Although relatively small-scale, this proposal for holiday lodges, with new infrastructure such as car parking and lighting, would be a damaging intrusion in the local landscape and would undermine the character and tranquillity of the World Heritage Site buffer zone. The location and the road access are unsuitable for a busy development of this kind.

Affordable Housing

We continue to speak up for the need for affordable housing in rural Derbyshire. For example, Halldale Quarry near Matlock, a brownfield proposal for more than 200 homes, which generally we support, has zero affordables in the mix. We have raised this with the council planners.

Derby and Derbyshire Minerals Plan

We have submitted a final response to the last version of the Minerals Plan to go out for public consultation. In spite of some improvements to the earlier version, we are still very concerned about proposed new sand and gravel sites at Foston and Sudbury in the lower Dove Valley, which will harm the landscape and bring industrial traffic to an essentially rural area.

Local Plans


We await the outcome of the Erewash, Derbyshire Dales and Amber Valley Local Plan reviews. We submitted detailed comments, urging the continued protection of green belt land and using brownfield land for housing, renewable energy and employment.

Bonsall Community Energy Visioning

In last year's annual report, we told you how we teamed up with CPRE Peak District and South Yorkshire to run a series of workshops with Bonsall residents, who were keen to promote local action to mitigate climate change.

The full report on the outcome of the project, illustrated with local scenes by local artist Christine Gregory, is now available on our website.
